Final Order

The matter at hand has come before the court, a court of record, by original writ petitioning the court to establish the facts as concerns the status of the Parties and the relationship one to the other.

4. is under the protection of the Crown and the "One Holy" all taxes and tithes prepaid.

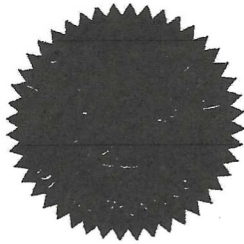
2. ANNA MARIA RIEZINGER, Birthed June 6, 1956;

Whereas I, the living woman known to the public as "Emma Ardith (Riezinger) Johnson", have known my Sister, a living woman known to the public as "Anna Maria Riezinger" and privately as Anna-Maria, for her entire life, and have known her parents and other family members also, I can readily and with confidence affirm that she was born on 6 June 1956 in Neillsville in Clark County, Wisconsin as the second daughter of Emmett Arthur Riezinger of Peoria, Illinois, and LaVera Myrtle (Schnur) Riezinger of Black River Falls, Wisconsin.

I am Anna Maria Riezinger's older Sister and was thirteen (13) years old at the time of her birth, so I have a complete recollection of all events related to her birth. I have kept in relatively constant contact with my Sister for her entire life. She lived the first twenty-five years of her life as a student and worker mostly in Wisconsin though she moved around a good deal. In 1981 she removed her permanent home to Alaska and has lived in Alaska ever since.

For the past almost twenty years Anna has lived in Big Lake, Alaska, and has maintained the same mailing address in care of a Post Office Box there. I have physically visited her and her husband James Clinton Belcher and her son Eric Jon Belcher at their home location consisting of two homes and two street addresses described as 2366 and 2390 South Park Road in Big Lake, Alaska.

Anna Maria Riezinger was the name the hospital was notified of upon my Sister's birth, but the actual historical name of our family is substantially different.

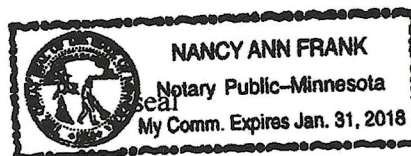
Anna-Maria has published work under several names and used these names for various purposes related to her work and private trade. Those names include variations of the basic name, such as "Anna M. Riezinger-von Reitz" and "Anna M. von Reitz" and "Anna von Reitz". These are all clearly related to the given name recorded and our family name(s) in general and are trade names used in private business. She maintains that her given name and trade names are her private intellectual property.
